Re: Request for Expedited Action on Building Electrification

Honorable Mayor and Councilmembers:

Given that the 2021-2022 Workplan will not be completed for approximately two months, the Climate Action Commission (CAC), seeks expedited action on discussion and consideration of a timetable, and possible ordinance and Reach Code, concerning building electrification regulations. This request was voted on and approved by the CAC during its April 21, 2021 meeting.

<u>Action Requested</u>: The Climate Action Commission calls on and recommends that the City Council schedule a discussion at the earliest possible time, preferably no later than May 2021, and consider:

- (a) the costs and benefits of BE to the Solana Beach community;
- (b) an aggressive schedule that would lead up to consideration of a building electrification ordinance;
- (c) pursuing a BE Reach Code through the California Energy Commission; and
- (d) obtaining a consultant to assist with the process of applying for a Reach Code. As noted, we currently have an offer of Pro Bono assistance with this.
