1. CALL TO ORDER

2. APPROVAL OF THE AGENDA

Motion: Moved by Councilperson Becker. Seconded by Commissioner Hegenauer. Approved: 6 yes; 0 no; 2 absent. **Motion Carried**.

3. INTRODUCTION OF NEW MEMBERS

New members, Lane Sharman and Heather Rock, introduced themselves to the Commission and Staff.

4. ORGANIZATIONAL: SELECTION OF CHAIR AND VICE CHAIR

Commissioner Basore nominated himself for Vice Chair.

Commissioner McClune nominated himself for Chair.

Motion to appoint Commissioner McClune to the position of Chair, and Commissioner Basore to the position of Vice Chair: Moved by Commissioner Sharman. Seconded by Councilmember Becker. Approved: 6 yes; 0 no; 2 absent. **Motion Carried**.

5. MAYOR'S INTRODUCTION AND WELCOME

Mayor Lesa Heebner addressed the Commission.

6. APPROVAL OF MINUTES OF PAST MEETINGS

A. Meeting of January 19, 2022

Motion: Moved by Commissioner Hegenauer. Seconded by Vice Chairperson Basore. Approved: 6 yes; 0 no; 2 absent. **Motion Carried.**

7. PUBLIC COMMENT

No public comment.

8. DISCUSSION REGARDING CAC SUBCOMMITTEES

Commissioners discussed their expectations of the CAC Subcommittees.

Mr. King noted that any subcommittee should be assigned a task with a specific end date.

Commissioners discuss possible subcommittees and when they should be formed.

Chairperson McClune asked how the CAC agenda is created. Mr. King answered that it is primarily created by Staff based on what has been discussed in previous meetings. Staff reviews the agenda with the Chair prior to each meeting.

Commissioner Hegenauer raised the issue of air quality and her desire to add the topic to the CAC's goals.

Chairperson Basore proposed to include a section on the agenda where Commissioners can formally raise items to the Council for consideration. Basore added that subcommittees should be formed to address items that the Council has asked the Commission to tackle. Mr. King said the approach Vice Chairperson Basore described is preferred by Staff and the best way to do this is through the City's work plan process, during which the Council sets the priorities for the year. In the past the CAC has

formulated plans for Council consideration during the work plan process.

Councilperson Becker reminded Commissioners to consider the Council priorities that Mayor Heebner shared at the top of the meeting (i.e., updating the CAP, including a social equity chapter).

9. ELECTRIFICATION REACH CODE UPDATES

Ms. Viskanta provided an update on the electrification reach code.

10. REGIONAL DECARBONIZATION FRAMEWORK PRESENTATION AND CLIMATE ACTION PLAN REVISION UPDATE – Rimga Viskanta

11. JUNIOR COMMISSIONER UPDATES

Ms. Viskanta provided an update on Fiesta Del Sol and noted that it will be a zero-waste event. It will also be the first public event where the plastics ban will be enforced.

Viskanta announced that volunteers are needed for the event.

12. NEW/PROPOSED BUSINESS: New or proposed business provides an opportunity for Commissioners to discuss items not on the agenda but that may be added to the CAC agenda/workload at a future date. Pursuant to the Brown Act, there will be no action taken on these items.

Commissioner Sharman recommended that The Council considers providing an incentive for carbon risk reduction (e.g., if methane supply line is terminated, the city will provide a monetary reward).

The Chamber of Commerce (Chamber) is making their children's events more eco-friendly. They are interested in planning a green scavenger hunt. Please send ideas for selfie locations at Fiesta Del Sol to Ms. Viskanta. The Chamber is also interested in adding a "green zone" where vendors could hold demonstrations of electric/green items.
