1. Call To Order And Roll Call:

5. Sales Tax Update – 4th Quarter 2020

Finance Director Ryan Smith reviewed the 4th quarter calendar year 2020 Sales Tax report provided by HDL Companies, the City's sales tax data consultant. He highlighted Year-over-Year changes in Sales Tax receipts for Solana Beach, San Diego County, and the State of California. Director Smith also reviewed a Sales and Use tax information guide provided by HDL. At the conclusion of the presentation, Director Smith and City Manager Greg Wade answered questions regarding the Sales Tax results.

6. March 31, 2020 Investment Report

Finance Director Ryan Smith reviewed the City's investment portfolio results, managed by Chandler Asset Management, at quarter ending March 31st, 2020. Director Smith also reviewed the March 31st results of the City's 115 Trust plan, managed by PARS and Highmark Capital. He discussed the most recent balances of the pension and OPEB trust funds and the investment results during the first three months of 2021. At the conclusion of the presentations, Commissioners asked questions about the investment programs that were answered by Director Smith and City Manager Greg Wade.

7. City Manager Roundtable

City Manager Greg Wade discussed current ongoing projects within the City, including Solana 101 and shared information regarding COVID, the upcoming Council meeting, legislative updates, and important topics currently affecting the City.
